

## Terms of Use

These Terms of Use govern your access to and use of the website [www.databazevseho.cz](http://www.databazevseho.cz) (hereinafter "**Web**") and all related content, which is owned and operated by CatchHotels.com s.r.o., Company ID: 178 70 771, with its registered office at Benediktská 691/5, Old Town, 110 00 Prague 1, incorporated in the Commercial Register maintained by Municipal Court in Prague, under File No. C 378119 (hereinafter "**CatchHotels**", "**we**", "**us**", "**our**") (hereinafter "**Terms of Use**", "**ToU**").

The Web is available to any visitor or customer (hereinafter "**User**", "**you**", "**your**"). Please read these Terms of Use carefully before accessing or using the Web. These Terms of Use limit our liability and may substantively affect your rights. Your access to and use of the Web constitutes your full and unconditional acceptance of these Terms of Use.
